

## Target Democratic Senators – 2011 Defense Authorization Bill

The following Democratic senators are potential targets whose votes we need to support Sen. McCain's objection to the motion to proceed (filibuster). The list has been derived by examining Democrats who may fall into any one or a combination of the following categories:

- Represent a “red” state (state that is believed to be conservative/Republican leaning politically).
- Are up for re-election (or in the case of primary defeats/retirements, are open seats).
- Have other background/characteristics that may make them receptive to arguments against repeal (e.g., Senator Daniel Inouye, though generally a reliable Democratic vote, chairs the Senate Defense Appropriations Subcommittee, or in the case of Bernie Sanders (I-VT), may generally *oppose* pro-defense legislation, and thereby be inclined to support a filibuster against the bill).
